# Application procedure for households exempt from the residence tax

Households deemed eligible for the monetary relief and are supporting children between 0 years old and high school age (born on or after April 2, 2005)

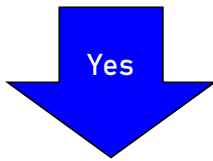

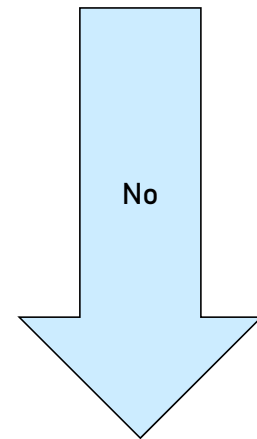
# Application procedure for households subject only to the flat rate residence tax

If any of the below conditions apply to you, you may be able to receive the monetary relief, provided that you submit the application form.

**Single-person households:**  
You moved in to Fukuoka City from outside of the city on or after January 2, 2023.

**Multiple-persons households:**  
Someone moved into your household from outside of the city including from overseas on or after January 2, 2023.

**All households:**  
By submitting amended tax returns or for any other reason, every individual of your household is exempt from the income-based residence tax for FY2023 and at least one individual is subject to the flat rate residence tax.
