

Information on FY2023 Emergency Monetary Relief for Rapidly Rising Prices

(¥70,000 per eligible household)

You must apply to receive this monetary relief.

▶ Who is eligible

Heads of households who are eligible for the monetary relief but have not received the notification because someone moved into their household on or after January 2, 2023.

Eligibility requirements:

- Households whose residence record was in Fukuoka City as of December 1, 2023.
- Households where every individual is currently exempt from the flat rate residence tax for FY2023.
- Households where no one has any undeclared income that would be subject to residence tax.
- Households that are not made up of only dependents of a person subject to the residence tax.
- Households that have not received the monetary relief of 70,000 yen under this scheme from any other municipality.

▶ How much is available

¥70,000 per household

▶ Timing of payment

The payment is made roughly 3 weeks after the city receives your application form.

⚠ Payments may take more time during busy periods.

You must apply to receive this monetary relief. To apply, fill out the application form entitled 令和5年度福岡市物価高騰緊急支援給付金申請書（請求書） [Application form for Fukuoka City FY2023 Emergency Monetary Relief for Rapidly Rising Prices] and return it by post.

Deadline: Tuesday, April 30, 2024 *Same day postmarks will be deemed valid.

▶ How to apply

- Check the following points before you send your documents:
 - If you have reported that you are exempt from residence tax due to a tax treaty, you are not eligible for the payment.
 - If the head or a member of your household has submitted an amended tax return and must pay the flat-rate part of residence tax, you are not eligible for the payment.
 - If the information on your application is false, you may have to repay the monetary relief. If you are found to have intentionally written false information, you could be charged with fraudulently receiving payments.
 - Households where all members were abroad as of January 1, 2023, do not qualify for monetary relief as they do not meet the requirement: "Every eligible individual in the household is exempt from the flat rate residence tax for FY2023."
- You must enclose supporting documents if you have filled in **3** 振込口座 **4** 代理人が受給、申請する場合
 - Check the required document section (**提出書類**) of your application form and the reverse side of the sample of the completed form.
△Your payment may be delayed if your documents are not complete as it takes time to check details.
- If you cannot open an account at a financial institution or are otherwise cannot receive funds through your account, contact the call center below.

You cannot hand in the form at a ward office or the city hall.

- Before sending your completed form back, double-check the following:
 - I have written **1** 申請者 [Applicant] **2** 申請者が属する世帯の状況 [applicant's household details] and have enclosed a copy of my personal identification.
 - I have filled in **3** 振込口座 [account details] and have enclosed copies of documents to verify my account, such as a copy of my bank book.



Beware fraudulent activities and identity theft!

- The city will never ask you to make any transactions at an ATM.
- The city will never visit your home regarding the monetary relief.

If you ever get a suspicious call or a visit from a person claiming to be from the city government, contact the police or call police consultation number (**# 9110**) immediately.
