

# FY2023 Emergency Monetary Relief for Rapidly Rising Prices

In response to rapidly rising prices, Fukuoka City is providing emergency monetary relief to help support financially struggling households.

## 1. Who is eligible

Heads of households whose residence records were in Fukuoka City as of December 1, 2023, and who meet the below requirements.

## 2. How much is available

Households where every individual was exempt from the residence tax for FY2023

¥70,000 per household

Households subject only to the flat rate residence tax for FY2023

¥100,000 per household

Additional relief (per child) for child-rearing households with low incomes  
¥50,000 per child

## 3. Eligibility requirements

### Universal requirements

- No one in your household has any undeclared income that would be subject to the residence tax.
- Your household is not made up of only dependents of a person subject to the residence tax.
- Your household has not received or is not due to receive the monetary relief of 70,000 yen under this scheme from any other municipality.

### Individual requirements

For households exempt from the residence tax  
Every individual of your household was exempt from the flat rate residence tax for FY2023.

or

For households subject only to the flat rate residence tax for FY2023  
Every individual of your household was exempt from the income-based residence tax for FY2023 and at least one individual is subject to the flat rate residence tax.

### Additional relief (per child) for child-rearing households with low incomes

You must be the head of a household that meets either of the two specific requirements stated above and are also a parent/guardian supporting a child born on or after April 2, 2005. △ If the head of the household is 18 years of age or younger, he/she is not eligible to receive the monetary relief.

## 4. Application deadline

**Tuesday, April 30, 2024**

\*Same day postmarks will be deemed valid.

△ Application deadline for the additional relief per child for households supporting newborns born on or after December 2, 2023 is **Saturday, August 31, 2024 (same day postmarks will be deemed valid)**.

The payment is planned to be made roughly 3 weeks after the city receives your application form.

△ Payments may take more time during busy periods.

**You cannot hand in your application form at a ward office or the city hall.**

## 5. How to Apply

If you are deemed eligible for the monetary relief, you will receive either *the Monetary Relief Payment Notification* or *Eligibility Requirement Confirmation Form*. Check them for details.

● If you received *Monetary Relief Payment Notification*

- In principle, no action is required. Your payment will be transferred to your account stated in the notification. The date of payment is also printed in your notification.

● If you received *Eligibility Requirement Confirmation Form*

- Fill out the *Eligibility Requirement Confirmation Form*, enclose supporting documents and return them by post.

△ If your household is subject only to the flat rate residence tax, you can apply for the relief using your smartphone. For details, check the *Eligibility Requirement Confirmation Form*.

● In the following cases, you may need to apply for the monetary relief even if your household is eligible for the relief.

For households exempt from residence tax or are subject only to the flat rate residence tax

- If any individual of your household moved into Fukuoka City on or after January 2, 2023.
- If your household has become eligible for the monetary relief after you have submitted an amended tax return or for any other reason.

For additional relief (per child) for child-rearing households with low incomes

- If you are supporting children (newborns) born on or after December 2, 2023.
- If you are supporting children aged 18 years or younger whose residence record is separate from that of your household because they are living in dormitories or for any other reason.

● If any of the following applies to you, you are not eligible for the monetary relief:

- If any individual in your household has reported that he/she is exempt from residence tax due to a tax treaty, he/she is not eligible for the payment.
- If the head or a member of your household has submitted an amended tax return and must pay the flat-rate part of residence tax, you are not eligible for the payment.
- If the information on your application is false, you may have to repay the monetary relief. If you are found to have intentionally written false information, you could be charged with fraudulently receiving payments.

● Fill in all required information on the confirmation or application form.

- Check the sample of the completed form to fill out your form.
- If you cannot open an account at a financial institution or are otherwise cannot receive funds through your account, contact the call center below. △Your payment will be delayed if it cannot be paid through your account.

● Return the form by post. Before sending your completed form back, double-check the following:

- I have filled in all required information.
- I have enclosed all required documents.

\*Your payment may be delayed if your documents are not complete as it takes time to check details.



### Beware fraudulent activities and identity theft!

- The city will never ask you to make any transactions at an ATM.
- The city will never visit your home regarding the monetary relief.

If you ever get a suspicious call or a visit from a person claiming to be from the city government, contact the police or call police consultation number (**# 9110**) immediately.
