

# Notice Regarding the Fixed-sum Tax Reduction Shortfall Benefit (Confirmation Form)

Application is required to receive shortfall benefits.

## About the shortfall benefit

To help ease the burden on household finances due to rising prices, fixed-sum tax reductions were implemented in FY2024 (a ¥30,000 reduction on income tax and a ¥10,000 reduction on the income-based portion of resident tax). Additionally, based on income received in 2023, individuals who were not expected to receive the full benefit of these reductions were provided with an adjustment benefit. After the final amounts of income tax and fixed-sum tax reductions for 2024 were confirmed, the benefit amount was then recalculated. Accordingly, a shortfall benefit will be provided to those whose previous benefit was found to be insufficient as a result of this recalculation.

## How to apply for the shortfall benefit

You must submit an application in order to receive the shortfall benefit. This Fixed-sum Tax Reduction Shortfall Benefit Confirmation Form has been sent to eligible individuals. Please submit the form along with copies of an identity verification document and a document verifying your bank account information.

**Application Deadline: Friday, October 31, 2025**

**Applications postmarked by this date will be deemed valid.**

Submissions made at city or ward office counters will not be accepted.

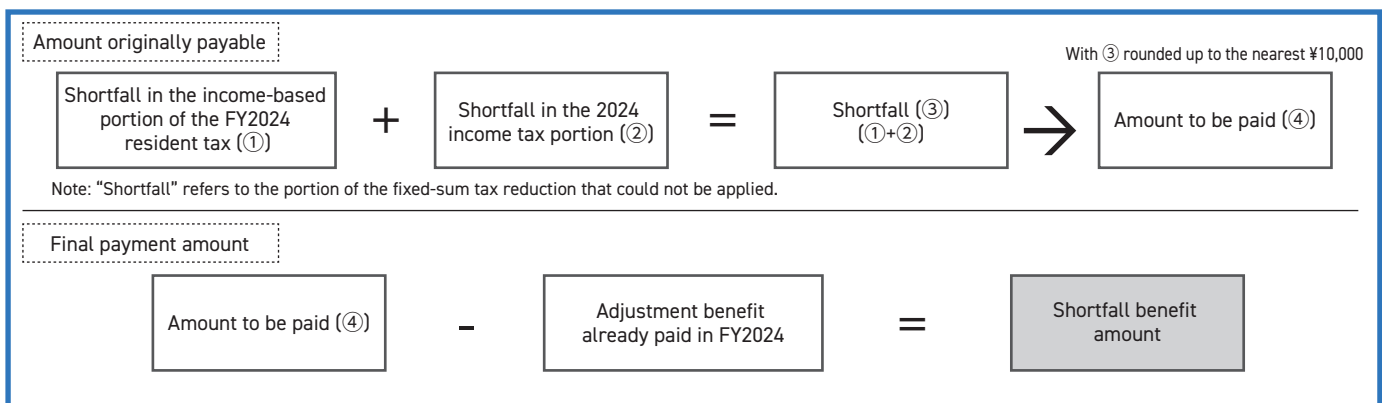
## Eligible recipients and benefit amounts

### Shortfall Benefit I

#### Eligible individuals

Individuals whose combined total of the following amounts exceeds the adjustment benefit previously received are eligible:  
 (i) The portion of the fixed-sum tax reduction that could not be applied to the FY2024 resident tax (shortfall in the income-based portion of the resident tax)  
 (ii) The portion of the fixed-sum tax reduction that could not be applied to the 2024 income tax (shortfall in the income tax portion)

### Shortfall Benefit II

#### Eligible individuals

Those who meet all of the following conditions are eligible:  
 ▽Exempt from both income tax and the income-based portion of resident tax  
 ▽Not considered a dependent under the tax system  
 ▽Not the head or a member of a household eligible for low-income household benefits

#### Benefit amount

¥40,000 (fixed amount)  
 Note: ¥30,000 (fixed amount) for those who resided outside Japan as of January 1, 2024

## ○ Please note the following before submission.

- If any of the fields are not filled in or any of the attachments are not clearly legible, your submission will be considered incomplete.
- If your submission is incomplete, we may contact you for clarification.
- Do not enter bank account details for an account that has not been used for an extended period.
- Only legal representatives, such as adult guardians, are permitted to receive the benefit on behalf of an applicant. Relatives or others who are not legal representatives are not eligible to receive the benefit. A family member who fills out the form on behalf of an applicant is not considered a legal representative. Therefore, be sure to provide the bank account details of an account held in the applicant's name.
- For a legal representative to apply for and receive the benefit, they must submit documents verifying their identity and their relationship to the applicant, such as a certified copy of family register or a document that confirms a court decision.  
Note: Only documents issued within the past three months will be accepted.
- Submitted documents will not be returned. Thank you for your understanding.

## ▶ When the shortfall benefit will be paid

Payment is expected to be made approximately three weeks after your application is received and approved by Fukuoka City. For the latest information, please check the Fukuoka City website.

Note: Payment may be delayed due to the review process or process of confirming submitted documents.

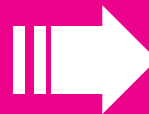
