# Notice Regarding the Fixed-sum Tax Reduction Shortfall Benefit (Application Form)

Those who have not received a notice or confirmation form regarding the shortfall benefit are required to submit an application form.

## About the shortfall benefit

To help ease the burden on household finances due to rising prices, fixed-sum tax reductions were implemented in FY2024 (a ¥30,000 reduction on income tax and a ¥10,000 reduction on the income-based portion of resident tax). Additionally, based on income received in 2023, individuals who were not expected to receive the full benefit of these reductions were provided with an adjustment benefit. After the final amounts of income tax and fixed-sum tax reductions for 2024 were confirmed, the benefit amount was then recalculated. Accordingly, a shortfall benefit will be provided to those whose previous benefit was found to be insufficient as a result of this recalculation.

## Eligible applicants

Individuals who may be eligible to apply for the shortfall benefit, such as those who moved to Fukuoka City from another municipality during 2024. (See the flowchart on the reverse side.)

Note: Please note that even if the flowchart indicates your eligibility to apply, you may still be found ineligible to receive the benefit as a result of the review.

## ► How to apply for the shortfall benefit


If the above condition applies to you, please submit an application form.

Those who have received the Fixed-sum Tax Reduction Shortfall Benefit Notice or the Fixed-sum Tax Reduction Shortfall Benefit Confirmation Form do not need to submit an application form.

Application Deadline: Friday, October 31, 2025
Applications postmarked by this date will be deemed valid.

Submissions made at city or ward office counters will not be accepted.

Please submit the form along with the required documents listed on the reverse side (copies of an identity verification document and a document verifying your bank account information).


## Shortfall Benefit I

The shortfall benefit amount is calculated as follows: (i) + (ii) - (iii)

Where

(i) = The portion of the fixed-sum tax reduction that could not be applied to the FY2024 resident tax (shortfall in the income-based portion of resident tax) (ii) = The portion of the fixed-sum tax reduction that could not be applied to the 2024 income tax (shortfall in the income tax portion)

(iii) = The adjustment benefit amount

## Required documents for application

#### (Required documents)

· Shortfall Benefit Application Form

Note: Enter the required information.

- Name and other details of the applicant (or legal representative)
- · Bank account designated to receive the benefit
- · Copy of identity verification document for the applicant (or legal representative)

Note: A copy of one valid document that verifies the applicant's name, address, and date of birth, such as a driver's license, health insurance card, My Number card (front side), or long-term care insurance certificate.

Note: If a legal representative applies on behalf of the applicant, a copy of one valid identification document is required for both the applicant and the legal representative.

· A copy of a document verifying the bank account designated to receive the benefit

A copy of a bankbook or cash card showing the name of the financial institution, branch name, account number, and account holder's name in katakana for the account designated to receive the benefit

(If a legal representative is to receive the benefit on behalf of the applicant)

· A copy of a document verifying their relationship to the applicant

One of the following documents: a certified copy of family register, a certificate of registered matters, or a document that confirms a court decision.

Note: Only documents issued within the past three months will be accepted.

#### < Shortfall Benefit I >

(Those who moved to Fukuoka City from another municipality during 2024)

- · A copy of the adjustment benefit decision notice or confirmation form (benefit notification)
- Those who were not eligible for the adjustment benefit, or who were eligible but cannot attach the above documents, must enclose the latest FY2024 resident tax notice, special withholding tax notice, or taxation certificate.
- Those whose FY2024 resident tax information has been revised since the initial issuance (June 2024) must enclose the latest FY2024 resident tax notice, special withholding tax notice, or taxation certificate.
   Note: If none of the above-mentioned FY2024 resident tax documents are enclosed, it will be assumed that no revisions have been made to your tax information.

(Those who resided abroad as of January 1, 2024, and moved to Fukuoka City during 2024)

• A copy of a document verifying their residence abroad, such as a company-issued transfer order, a certificate of residence, or other similar documents

(Those who have maintained resident registration in Fukuoka City without interruption since January 1, 2024)

- (If there has been a revision to your 2024 income tax)
   A copy of the 2024 withholding tax slip or final tax return
- (If there has been a revision to your FY2024 resident tax)
  A copy of the FY2024 resident tax declaration form or the latest tax notice

(Those who moved to Fukuoka City from another municipality during 2024)

· A copy of the latest FY2024 individual resident tax notice or taxation certificate

(Blue return family employees or other family business employees)


• A copy of the business owner's 2024 income tax return or the notification form concerning blue return family employees

Note: The FY2024 taxation certificate must be obtained from the municipality where you resided as of January 1, 2024.

< Flowchart for Shortfall Benefit I Eligibility >





## ► When the shortfall benefit will be paid

Payment may take approximately one month after your application is received and approved by Fukuoka City.

Payment may be delayed due to incompleteness, missing attachments, or verification of your benefit status with other municipalities. Once the review is complete, we will send a Notice of Benefit Decision stating the payment amount and date to those who are eligible.
